

In reference to your OPRA requests, 400 Broadway, 15-17 South 7th Avenue and 179 Branchport Avenue. Please be advised that 15-17 South Seventh was provided approvals as a self-storage area. The storage bins are not business uses per se and upon use by an individual a Certificate of Occupancy or Fire Inspection is not made at that time, however, inspections are made on an annual basis of the facility. If it is storage for personal use, there is no CO. If a business is operating out of a unit then it gets a CCO and is inspected annually. The same status was granted to 179 Branchport Avenue, pursuant to its application and approval by the either Zoning Board or Planning Board. If it is storage for personal use there is no CCO as it is covered by the Site CCO. In no way do these units do any retail selling to the general public. Please be advised that should you desire to have the same status conveyed upon your property you would have to apply for such status.

Please also be advised, that if your complaint is that the City has reacted too slowly to your various applications, I again invite you to meet with City officials to discuss a methodology to work out any problem that you may have.


